1. APOLOGIES

3. POLICE REPORT

PC Stothers reported the following crime statistics comparing June 2002 with June

Pc Stothers stated the increase in vehicle crime was not in specific areas but generally. The council was also informed that the West Yorkshire force was currently in a recruitment drive and a significant number of the new police will be coming to the Keighley Division.

Cllrs again raised the issue of illegal parking on the streets and urged the police to do more to resolve the situation.

5. MATTERS ARISING FROM THE MINUTES OF THE LAST MEETING.

It was confirmed that speed enforcement action would be taken in Silsden between now and the end of July.

Cllr were asked to prepare question for Mr Preece re the UDP and Cllr Richardson of the Police authority, to be given to the clerk at the next planning meeting.

The clerk confirmed that Ann Cryer MP could attend the August meeting, it was felt that September would be better for this council.

Cllr Chilton gave an update on the information he had obtained on the Bradley green Culvert, the council have just had meetings with the residents but no more is known as yet.

7. PARK RANGERS.

A discussion took place between the council and the Park ranger service. The council were given an outline of the Rangers duties and powers. The Rangers explained how the work closely with the police, but that there limited powers meant that were only there as 'eyes and ears'. A contact number for anybody wanting to make specific requests for a Ranger Service was given as <u>01274 432697</u>. It was also confirmed that the Ranger service for the whole of the Bradford district was given funding of approximately £400,000 per year. Mr John Scofield, the person with overall control of all parks and open spaces also gave his contact number <u>01535 618265</u>.

8. SWIMSTART.

It was proposed that a specific meeting be arranged for the councillors to be updated on the present situation. Cllr Atkinson requested that this be a full meeting, Cllr Elsmore seconded this with all in favour.

The monthly report of the Swimstart group was read out by the clerk, which states that the lessons are fully booked, and a waiting list for most. They are also entering a float in the carnival and further fund raising events such as a plastic duck race and coffee morning are planned.
