- 1. APOLOGIES FOR ABSENCE.- Cllrs Naylor, Atkinson, Philips & Bromley
- DECLARATION OF INTEREST Cllr Walton Prejudicial Interest in police matters was declared.
- 3. UDP The mayor wished to publicly thank all the various groups in Silsden, who he felt, did a great service to the Town in their fight against the UDP. Cllr Elsmore confirmed the governments definition of a rural town to be that of a population under 10,000 surrounded by Greenfield's. Silsden obviously fitted directly into this categorisation.
 - Cllr Walton proposed, seconded by Cllr Bottomley with all in favour that a letter is sent to Andy Haigh and Margaret Eaton to urge BMDC to accept the inspector's recommendations in connection with Silsden.
- 4. POLICE REPORT. PC Stothers updated the council with regards to recent press reports. The question was asked whether initiatives in Keighley and Bradford against drugs was and would cause the problems to be displaced to Silsden. PC Stothers state there was no evidence to show that this may be happening. The mayor and PC Stothers reiterated that the cllrs and members of the public had a duty to report incident to the police before they go to the press. Cllrs are also reminded that they must ensure any such press reports as representative of their individual views and not that of the Town Council. Any Town Council press release will be issued through the clerk. Cllr Trainor updated the council on the newly formed Craven Tasking group. Complaints and reports of incidents should now be taken to this forum via CIIr Trainor or PCSO Walton. A report from this forum will be given at each council meeting. It was agreed that cllrs wishing to report any such matters are best reporting to the forum as soon as they have been made aware of any incidents, rather that waiting for council to sit and this will allow police more time to act. Comment made By Cllr Savage will be taken to the next Craven Tasking meeting. It was resolved that the agenda item 'Police report' will now be reamed to 'Craven Tasking Group Update'.
- MINUTES That the minutes of the meeting of Silsden Town Council held on 1st July 2004 were signed as a true and accurate record after proposal from Cllr Trainor and seconded by Cllr Savage with all in favour.
- 6. MATTERS ARISING Item 15 this was taken in connection with the public adjournment as a member of the public wished to complain about the nettle and rubbish on the pathway between Skipton Rd and Park Green. The clerk confirmed that she was chasing this item. A new log number was given as **102894.** The clerk requested she be kept advised if the path was not clean and cleared within the next 2 weeks.
 - Cllr Elsmore represented all the PCs and TCs that were unable to attend the Yorkshire Days celebrations in Leeds. He received some information on the Yorkshire society. It was resolved to place this item on the September finance agenda.
