

MINUTES OF THE MEETING OF SILSDEN TOWN COUNCIL

1. Apologies for absence were received and accepted from Cllrs Croft, A Conway and K Conway
2. No declaration of interest on items on the agenda
3. POLICE update was read out. Insp Sanderson confirmed crime was low and that there had been no priority crime in the last month. The police were thanked for the presence and help at the Grand DeParty. Parking issues were once again raised for Clogg Bridge, Howden Rd, Aireview, New Road. The apparent increase on people driving through the town using their mobile phones was also brought to the police's attention. Public adjournment was taken at this time as the police were asked what they could do to help Silsden AFC with regards to parking problems on match days. Police stated that this was a Bradford council issue. Cllr Naylor to check whereabouts the request for yellow lining sits on Bradford's to do list.
4. The minutes of the meeting of Silsden Town Council held on 4th June 2015 were signed as a true and accurate record.

6. Noted the clerk has received confirmation that the flowers for the beds in Wesley Place are purchased and on Bradford's to do list, and were planted by the time of the meeting.

It was suggested that this land still belongs to the builders, this information will be fed back to the enquirer.
